1) Answer: b) Agriculture

Explanation:

The National Green Hydrogen Mission primarily focuses on decarbonizing key sectors such as steel, shipping, and mobility, which are responsible for significant greenhouse gas emissions. Agriculture, while important for environmental sustainability, is not a primary focus of this mission, which targets more industrial and energy-intensive sectors.

2) **Answer:** b) Bombing a military installation to destroy communication infrastructure.

Explanation:

Bombing a military installation is an example of kinetic warfare, which involves physical combat and destruction. Non-kinetic warfare includes tactics like cyberattacks, disinformation, and electronic jamming, which disrupt critical infrastructure or public sentiment without direct physical attacks.

Artificial stone (engineered stone or quartz) contains over 90% silica, posing a higher risk of silicosis compared to natural stones like marble and granite. Cutting or polishing artificial stone

generates fine silica dust, which can lead to severe lung diseases when inhaled.
